1.1. What these terms cover.

These are the terms and conditions under which we offer the Telegraph & Guardian cashback promotion on our products (defined as the ZEB) that has been manufactured by tepeo and supplied in the United Kingdom) to you (the Customer). We may change these Terms from time to time.

1.2. Why you should read them.

It is important that you read these Terms carefully before you register for or claim the Offer available in this Promotion.

1.3. Interpretation of these Terms.

"We", "us" or "our" refers to tepeo Limited ("tepeo") the Company providing the offer. "You", "your" refers to the Customer who purchases and owns the tepeo Product. When we use the words "writing" or "written" in these Terms, this includes digital communications such as emails and text messages.

# 3. TELEGRAPH, GUARDIAN & EVENING STANDARD CASHBACK OFFER TERMS AND CONDITIONS:

- 3.1. Offer is available with tepeo in the UK and Jersey and can only be used by a customer where tepeo currently delivers and installs.
- 3.2. The cashback offer is for new customers of tepeo only.
- 3.3. Any offers will be automatically voided if the customer decides to cancel their purchase from tepeo. The cashback is only successful once the purchase is completed, and the ZEB installed and commissioned by a tepeoPRO installer.
- 3.4. The customer needs to quote the offer discount code (the "Discount Code") shown in the Guardian, Telegraph & Evening Standard adverts on 31.08.24, 04.09.24 and 10.09.24 respectively (the "Adverts") when their ZEB order is being placed, and have the ZEB installed and commissioned within 3 months of the publication of the Adverts, excluding issues due to tepeo fault i.e. tepeo not being able to arrange an installer in time.
- 3.5. The offer is not valid in conjunction with any other offer, promotion or discount.
- 3.6. One Discount Code only per customer.
- 3.7. Offer is valid on the ZEB only and not in relation to any other products or services sold by tepeo or a tepeoPRO.
- 3.8. The customer will be transferred the £250 cashback within 4 weeks of the ZEB being installed and commissioned. During busy periods, this may take longer.

- 3.11. These terms are governed by English law and you can bring legal proceedings in respect of the products in the English courts. If you live in Scotland you can bring legal proceedings in respect of the products in either the Scottish or the English courts. If you live in Northern Ireland you can bring legal proceedings in respect of the products in either the Northern Irish or the English courts.
